14/11/18	Provision of School Places in Telford and Wrekin 2018-2023 Purpose: It is the Council's role to plan, commission and organise school places in a way that promotes the raising of standards, manages supply and demand and creates a diverse infrastructure. In a period of financial challenge, the Council is committed to providing accommodation for school places, whether permanent or temporary, that is high quality, fit for purpose, provides value for money and ensures flexibility to respond to changes in need and curriculum. In order to secure a sufficiency of school places it is necessary to ascertain the future pupil places needed within the Borough. The School Organisation team undertakes an annual analysis of the current and future demand for places using census data, housing growth projections and live birth data, and produces a strategy for meeting this demand into the future so that all children can access a good school place within their locality. The report recommends that cabinet takes note of all the information in the School Organisation Plan with a view to future provision of school places across the Borough and authorises the Assistant Director: Education & Corporate Parenting, in consultation with the Lead member for Education & Skills to take all required action to meet the emerging demands for the provision of school places across the Borough. 	In order to be able to provide appropriate					
	provision to meet these needs well into the					
	future, the proposal is to develop specialist					
	resource bases in mainstream schools, which					
	is currently underdeveloped in the local					
	area. There is also a need to consider some					
	capital work within our special school estate to					
	manage increasing numbers, albeit our longer					
	term strategy is to minimise special school					
	expansion as far as possible, given Telford					
	already places more children in special schools					
	than the national average. We will focus our					
	attention on promoting inclusion within					
	mainstream schools and widening our					
	continuum of provision through the					
	development of resource bases. The report					
	recommends that Cabinet takes note of all the					
	information in the High Need Review and					
	Strategic Plan for SEND, approving the					
	strategy for meeting the future needs of					
	children with SEND, including further					
	development of resource provision					
	and authorises the Assistant Director:					
	Education & Corporate Parenting, in
